HIRING REFUGEES IN BULGARIA

#STRONGERTOGETHER



Employers can hire Ukrainian citizens **without the need for a work permit** if they have been granted:

- **the right to asylum** or
- **international protection in Bulgaria** or
- for whom there is an **international agreement** with Bulgaria.

Citizens of Ukraine who have applied for international protection, but in which the proceedings **have not been completed before three months** from the date of filing the application for reasons beyond their control, **also have the right to access the labor market**.

In order to be hired, they must provide the employer with:

- a card for a person with a **refugee status** or
- a card for a person with **humanitarian status**.

If a person is still in the status acquisition procedure, **he must submit a document of residence in Bulgaria issued by the competent authority** and **a memo issued by the State Agency for Refugees** under the Council of Ministers on the existence of circumstances under Article 29, al. 3 of the Law on Asylum and Refugees.
